#### Public Licence Provision

- 1. All AFARM shall ensure that the licence remains valid while carrying out their duties and functions in any Ports in Brunei Darussalam.
- All AFARM shall comply with the Maritime and Port Authority of Brunei Darussalam's Orders and Regulations and other government agencies' rules and regulations.
- 3. All AFARM shall comply with the requirements of the Maritime and Port Authority of Brunei Darussalam (MPABD).
- All AFARM shall, in the manner and at the times specified by MPABD, publish the standard terms and conditions, including tariffs, under which it provides freight forwarding services to customers.
- 5. All AFARM shall publish all such tariffs and make them available to all customers.
- The MPABD may where it thinks fit, control or fix the prices to be charged by all AFARM in respect of the provision of the freight forwarding services including the setting of pricing policies or principles.
- 7. All AFARM shall comply with any direction issued by the MPABD or the purpose of preventing any market abuse or any practice or arrangement that has the object or effect of preventing, restricting or distorting competition in the establishment and operation of freight forwarding services.
- 8. All AFARM shall develop and operate the licenced freight forwarding services so to as progressively to achieve standards in line with best practices, relevant standards and other benchmarks as the MPABD may direct from time to time.
- 9. All AFARM shall maintain a high level of port security in accordance with the Maritime and Port Authority of Brunei Darussalam (MPABD) Order, the International Maritime Organisation's (IMO's) International Ship and Port Facility Security (ISPS) Code, and any other direction that may be issued from time to time by the MPABD or any other relevant agencies so authorised under the written laws of Brunei Darussalam.
- All AFARM shall cooperate with the MPABD and relevant government security agencies in training activities, exercises and drills which
  are aimed at maintaining or improving port security.
- 11. The MPABD may require AFARM's employees to undergo or attend any relevant trainings, examinations and/or briefing sessions before or during the course of operations and the cost of such trainings, examinations and/or briefing sessions shall be borne by the AFARM.
- 12. All AFARM shall make its best efforts to engage or employ Brunei citizens (highest priority) or Permanent Residents for the management and provision of the freight forwarding services.
- 13. All AFARM shall cooperate with MPABD and relevant government agencies in upkeeping the safety, environmental protection of the port of Brunei Darussalam under the purview of the MPABD.
- 14. All AFARM are required to be registered to the Brunei Darussalam National Single Window (BDNSW).
- 15. All AFARM shall adhere to the KPI's set by the MPABD in supporting the Ease of Doing Business (EODB) initiatives.
- 16. Any changes of particulars or details of AFARM shall be informed in writing to Port Master, MPABD.
- 17. Failure to comply with these provisions and orders from Port Master, MPABD has the right to suspend / revoke / cancel this licence.
- 18. Renewal application of this licence shall be submitted to the MPABD at least one (1) month before expiry date.
- 19. The MPABD has the right to omit, add or amend any of these provisions.
